ELIGIBLE VEHICLES

Chrysler Group and competitive-make vehicles covered by a minimum of a 3/36 Basic Warranty are **eligible within 48 months of the in-service date and 48,000 miles (excludes Sprinter & Ram Cab/Chassis)**. See your dealer for additional vehicle eligibility, exclusions, and applicable specialty class categories.

NOTE: The following are not eligible for Mopar Vehicle Protection MECHANICAL COVERAGE: Vehicles registered outside of the United States, Guam and Puerto Rico; right hand drive vehicles; motor homes; taxis or limousines (except vehicles placed in van pool service); emergency vehicles (ambulance, fire, police); vehicles used for postal service; vehicles used for severe off-road use; vehicles converted from two- to four-wheel drive; vehicles altered or converted from the original manufacturer's specifications; vehicles not used in accordance with manufacturer's specifications for payload and/or towing capacity; vehicles equipped with a diesel engine (except Chrysler Group, Ford and General Motors); vehicles that operate on other than gasoline or diesel fuel systems (e.g. natural gas, electric, hybrid gas/electric vehicles); vehicles equipped with NorthStar engines; vehicles equipped with engines greater than 8 cylinders; vehicles with a gross weight (G.V.W.) of over 14,000 pounds; one-ton vehicles used for commercial use (e.g. snowplows); cab and chassis vehicles (e.g. dump trucks); vehicles where the factory warranty has been voided or restricted by the manufacturer; vehicles that have been declared to be a total loss by any insurance company, are rebuilt after being declared a total loss, or are issued a title indicating that designates it as 'salvage', 'junk', 'rebuilt' or words of similar impact.

NOTE: Special mechanical coverage is available for the following Chrysler Group vehicles ONLY: Police; vehicles equipped with engines greater than 8 cylinders; Ram trucks with a gross weight (G.V.W.) of over 14,000 pounds; one-ton vehicles used for commercial use (e.g. snowplows); cab and chassis vehicles (e.g. dump trucks); hybrid/electric vehicles.

"SIGN-AND-GO" ROADSIDE ASSISTANCE

Plan provides 24-hour "Sign-And-Go" Towing and Roadside Assistance (up to \$100 per occurrence). Benefits include towing, flat tire change (with your good spare), battery jump, out-of-gas fuel delivery (2 gallon maximum), and lockout service (i.e., keys locked in vehicle or frozen lock). Towing assistance will be dispatched only for mechanical disablement which renders the vehicle inoperable.

TOWING ALLOWANCE

Maximum Care will pay up to \$100 per repair occurrence for towing to the nearest Chrysler Group dealer anytime a component covered by the Plan fails, requiring the vehicle to be towed. Towing charges in excess of the amount allowed by the Plan are your responsibility.

FIRST DAY RENTAL/CAR RENTAL ALLOWANCE*

Maximum Care provides a \$35 First Day Car Rental Allowance for any dealership mechanical repair or maintenance service. This plan will also pay up to \$35 per day (\$175 maximum per occurrence) anytime a covered component described in your Plan Provision fails, causing the vehicle to be both inoperable and require overnight repairs. Car rental allowance coverage is not provided where loaner vehicle coverage is provided by the warranty or the dealer. Also provides for \$35 Taxi Reimbursement in lieu of Rental Allowance.

*The rental car must be obtained from a dealer or from a licensed rental agency. Rental coverage is subject to state and local laws and those imposed by the rental agency. Chrysler Group is not responsible for any refusal of a rental agency to rent a vehicle to you.

TRIP INTERRUPTION COVERAGE

The Plan will pay up to \$1,000 for lodging, meals and car rental expenses if: (1) the vehicle is inoperable due to a failure covered by the service contract or the factory warranty, and (2) the failure occurs more than 100 miles from home.

TRANSFER POLICY

A service contract can make your vehicle more valuable and easier to sell. Remaining Plan coverage may be transferred to the subsequent purchaser of the vehicle at the time of vehicle sale (Lifetime plans are not transferable except in the state of Florida [\$40 transfer fee] and North Carolina [\$50 transfer fee]).
